## PLEASE OBSERVE THESE SIMPLE RULES:

- SHOPPING IS LIMITED TO ONE VISIT PER WEEK
- PLEASE LIMIT SHOPPING TIME TO 20 MINUTES.
- ITEMS TAKEN ARE NOT TO BE SOLD.
- THERE IS A LIMIT OF 4 ITEMS PER PERSON - EXCEPT CLOTHING.
- LIMIT OF 5 BOOKS.
- PLEASE HELP KEEP CLOTHING NEATLY FOLDED OR HUNG UP.
- PLEASE RESPECT THE GENEROSITY OF OTHERS. TAKE ONLY WHAT YOU NEED.
- FAILURE TO ABIDE BY THE GUIDELINES WILL RESULT IN PERMANENT DISMISSAL FROM THE STORE.

- HATS OR UNDERCLOTHING
- UPHOLSTERED FURNITURE, BEDDING, MATTRESSES, PILLOWS
- BOOKS WITH MISSING PAGES / COVERS
- POTENTIALLY HAZARDOUS ITEMS DUE TO FLAWS OR FAULTS
- FOOD ITEMS
