Difficult Disposal Days Are Back

Our Difficult Disposal Days provide residents a reminder of the services we offer year-round for "difficult" items, including household hazardous waste (HHW), electronics, and refrigerant-containing appliances, that are potentially harmful to human health and our environment if disposed of improperly.

We accept HHW year-round at our facility in Jefferson County. But with our special mobile HHW collections, we bring this service to your local Recycle Center twice each year. HHW disposal is always available at no charge.

You can also recycle electronics and refrigerant appliances year-round at our Recycle Centers. However, we do charge fees. On the Difficult Disposal Days at each Recycle Center, we accept one item per household at no charge, offering residents a savings.



May – Household Hazardous Waste

We will host special mobile HHW collections throughout the District. There is no mobile collection in Jefferson County since the facility in Madison accepts HHW year-round.

June – Electronics with Screens

TVs, computer monitors, or other items with a screen can be recycled free of charge on select dates at each County Recycle Center. We will accept ONE item per residence, at no cost, on these dates during the center's normal operating hours. Additional electronics will be accepted for

July - Refrigerant Appliances

Refrigerators, air conditioners, dehumidifiers, and any other appliances containing a refrigerant will be accepted at no charge on select dates at each County Recycle Center. We will accept ONE item per residence, free of charge, on these dates during the center's normal operating hours. Additional appliances will be accepted for the normal fees.

Frequently Asked Questions

Over the years, SEIRD has fielded countless questions from community members about how to recycle right. Here are answers to some of the questions we hear most often.

Do you purchase aluminum cans and scrap metal?

No, we do not pay for these items. We use the revenue made from these materials to fund our program operations, as well as our education outreach efforts, such as our "One Man's Trash..." and "Trash Talk! publications and programs held at local schools.

What do I do with old paints and stains?

We accept oil-based paints and stains during our mobile household hazardous waste collections offered twice a year at the Recycle Centers and year-round at the Jefferson County Recycle Center, which is located inside the old Jefferson Proving Ground. We do not accept latex paint. Dry out latex paint and then dispose of it with your household trash.

How do I dry out latex paint?

Pop off the lid and let the sun dry it out or add shredded newspaper or kitty litter and mix until it is solid.

Do you accept all plastics?

No. The recycling market for different types of plastics is ever-changing. Currently, we accept bottle- or jug-shaped #1 or #2 plastics at all Recycle Centers. We ask that all other shapes of #1 and #2 plastics be placed into the trash. In addition, #5 plastics (any and all shapes) are now accepted for recycling ONLY at the Batesville Area, Jefferson County, Ohio County, Ripley



County, Scott County, and Switzerland County Recycle Centers. Stay tuned, as guidelines may change in the future with market changes.

What do I do with my yogurt and cottage cheese containers?

If the containers are a #5 plastic, they are now accepted ONLY at the Batesville Area, Jefferson County, Ohio County, Ripley County, Scott County, and Switzerland County Recycle Centers. Unfortunately, we do not currently have an outlet for plastics #4 or #6. These containers can be reused around the house in a variety of ways, such as for storage, as garden pots, or in craft projects. Otherwise, they must be placed with your trash destined for the landfill.

You did not pick up my curbside recyclables. What happened?

While we help communities develop curbside recycling programs, we do not provide these services directly. Please check with your city or town to find out what company picks up your curbside recycling and then contact that company.

Can I bring you my used or worn-out vehicle?

No, we do not accept vehicles. Please contact a local scrap metal company to dispose of your vehicle.

Maintaining a vibrant and healthy lawn while being environmentally conscious may seem like a balancing act, but there's a simple and effective practice that can help achieve both goals — grasscycling. This eco-friendly approach involves leaving grass clippings on your lawn after mowing rather than bagging and disposing of them.

Grasscycling is essentially a recycling process for your lawn. Instead of handling grass clippings as waste, you simply let them remain on the lawn to decompose naturally. As you mow, the clippings are scattered across the grass, providing a layer of organic matter that benefits both the soil and the growing grass.

Grass clippings are rich in nutrients like nitrogen, phosphorus, and potassium. By leaving them on the lawn, you're returning these essential nutrients to the soil, acting as a natural fertilizer. This promotes healthier grass growth and reduces the need for synthetic fertilizers. Grass clippings also act as a natural mulch, helping to retain soil moisture. This means your lawn will require less water, contributing to water conservation efforts and reducing your overall water consumption. Embracing grasscycling significantly decreases the amount of yard waste generated. Instead of filling up bags with clippings destined for the landfill, you're allowing nature to recycle them onsite, minimizing your environmental impact.

Here are some tips to effectively grasscycle:

- Set your mower at the right height. Aim to cut only the top one-third of the grass blades, leaving the clippings small enough to decompose quickly.
- Stick to a regular mowing schedule to ensure that clippings are of manageable size. Infrequent mowing may lead to longer clippings that can smother the grass underneath.
- Mow when the grass is dry. Wet clippings can clump together, hindering their decomposition.

Grasscycling is a simple yet impactful practice that benefits both your lawn and the environment. By embracing this approach, you're not only taking care of your grass, but you're also contributing to reduced waste and water conservation. So, the next time you reach for the lawnmower, think about letting those clippings stay right where they belong — on your lawn.

SEIRD Reuse Centers are the perfect way for residents to save money, natural resources, and energy by finding new owners for unwanted and gently used merchandise.

Everything at our Reuse Centers is free. You won't find a better deal than that anywhere! All we ask is that you use it for your personal use and don't resell it. Clean, gently used merchandise in good condition can be dropped off and obtained during the center's normal business hours. Clothing, shoes, books, office supplies, videos/CDs, knickknacks, and non-upholstered furniture are just a few of the items that are accepted and available at SEIRD Reuse Centers. The SEIRD Building Materials Reuse Center in East Enterprise can accept a variety of items, including fixtures, windows, doors, sinks, building supplies, and more. That center, located at 19 McCreary Ridge Road, East Enterprise, is open Monday and Wednesday, from noon until 6 p.m., and Saturday, from 8 a.m. until noon.

Reviving Gadgets

Electronics recycling is the process of collecting, dismantling, and reusing or refurbishing electronic devices. It is an essential practice in today's world where electronic waste has become a significant environmental concern. Electronic devices contain various hazardous materials, such as lead, mercury, and cadmium, which can cause serious harm to the environment if not handled correctly. By recycling our electronic devices, we prevent these harmful substances from contaminating soil and water when disposed of improperly or from ending up in landfills.

So how do you handle electronic devices in a sustainable and responsible manner? First, strive to extend the lifespan of devices by taking good care of them,


protecting them and investing in repairs as necessary. This reduces the demand for new products and the associated environmental impact of both manufacturing and disposal.

In some cases, manufacturers and retailers may offer recycling programs and even discounts on new devices when you trade in an old one. Otherwise, be sure to recycle your old electronics at your county Recycle Center.

By taking care of our devices while we are using them and after we are done with them, we contribute to a more sustainable future and minimize the environmental impact of our electronic devices.





Wasted! The Story of Food Waste



Safely Dispose of Unwanted Medications

The Southeastern Indiana Recycling District (SEIRD) partners with local police and sheriff's departments throughout our seven-county District to provide year-round pharmaceutical (medication) disposal opportunities for residents. Folks who live in Franklin, Jefferson, Jennings, Ohio, Ripley, Scott, and Switzerland counties can dispose of unwanted medication waste including expired and unused/unwanted controlled and uncontrolled substances — 24 hours a day, 7 days a week. Flushing medications down the drain sends them into the water supply, where they can easily pose a threat to our health and safety.

Proper disposal of medications is easy and FREE, and no questions will be asked. To find the location nearest you, visit our website at www.seird.org or call our office.





Discarding trash or other unwanted items in empty lots, along highways, or in other nonapproved locations is considered illegal dumping, and it is against the law. Dumped items frequently include furniture, appliances, tires, construction waste, household trash, and hazardous materials. Oftentimes these illegally dumped items attract curious children posing significant health and safety risks. Dirty diapers and food trash attract rodents, insects, and other vermin. Dumping items pollutes the soil and water and destroys Indiana's natural beauty. Please be sure to landfill or recycle items you no longer want or need.

To report illegal dumping, please contact the Indiana Department of Environmental Management (IDEM) online at www.in.gov/idem/5274.htm or call 800-451-6027 and select option 3. All reports are confidential.

Ready to Clear Out Old Tax Paperwork?



Residents of our District can deliver sensitive documents, such as old financial and tax documents, for secure shredding to any of our Recycle Centers. There is a limit of three banker-sized (or similar) boxes per residence per visit. You do not need to remove staples, but please remove all metal tabs and metal reinforcements from hanging file folders, paper clips, clamp clips, etc.

When you deliver your documents to the Recycle Center, you will place them into a locked, tamper-proof container. When the container is full, it will be transferred to our facility in Madison where the contents will be shredded. If you are uncomfortable leaving your documents, you may call our office at 812-574-4080. We will be happy to make an appointment so you can deliver documents directly to the Jefferson County Recycle Center in Madison to personally watch them be shredded.

This is a program for residents and their personal, confidential papers only — please, no business documents.

Which automotive waste items are acceptable?

We can help you recycle used motor oil, hydraulic fluid, and antifreeze. Although used, these wastes must be otherwise clean and non-contaminated by other substances. There is a limit for these fluids of 10 gallons per person per visit. We also recycle oil filters, automotive batteries, and tires.

Do you take tires?

Yes, but there are fees, which vary depending upon the type of tire. Please visit www.seird.org and view your Recycle Center brochure for a full list of accepted tires, fees, and limits.

Which electronics do you charge for?

There is a \$15 recycling fee charged for items with a screen, such as computer monitors, laptops/tablets, and TVs. This fee helps offset the costs we incur in handling these items.

Do you accept...

Styrofoam?

No, not at this time. Bag it and place it into your trash to go to the landfill.

Window glass?

No. Only food and beverage glass bottles and jars are accepted.

Alkaline batteries?

No, alkaline batteries no longer contain

Metal fencing?

Yes, but it must be rolled up and tied off or placed inside of a metal drum. Place in the scrap metal container.

Lumber?

No. Try to reuse old lumber or dispose of it at the landfill. Ask your crafty friends or search online for countless projects that reuse old lumber.



Pool chemicals?

Yes, but only during HHW mobile collection days or at the Jefferson County Recycle Center during normal business hours. Keep pool chemicals in their original containers and do not mix them with other chemicals.

Cleaning chemicals?

Yes, but only during HHW mobile collection days or at the Jefferson County Recycle Center during normal business hours. Keep cleaning chemicals in their original containers and do not mix them with other chemicals.

Unlabeled HHW?

No, for safety reasons, unlabeled chemicals, cleaners, and related liquids are not acceptable. Keep all Household Hazardous Waste (HHW) in its original, labeled container.

Mattresses?

No, we cannot recycle mattresses, and they must go to a landfill or transfer station.

Furniture?

Clean, non-upholstered, usable furniture may be taken to your nearest Reuse Store. All other furniture must go to the landfill
